This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

INFORMATION WE MAY COLLECT FROM YOU

We may collect and process the following data about you:

- Information that you provide by filling in forms on our website. This includes information provided at the time of making bookings through our website;
- If you write to us (by letter or email), we may keep a record of that correspondence;
- If you telephone us or we telephone you, we may keep a written record of that conversation.
- Details of transactions you carry out through our website and of the fulfillment of your bookings;
- Details of your visits to our website including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a server. 1. ABOUT YOU

By making a booking, you confirm that:

• You are able to attend for your chosen investigation or check-up at the selected appointment time.

2. MAKING A BOOKING

• Once you have decided you want to book an appointment there is a booking fee £50.00 advance, you will have to pay. This will be reimbursed when you come for your appointment. You will receive an e-mail from us acknowledging that we have received your booking.

3. PRICE AND PAYMENT

- The prices for the investigations and check-ups will be as quoted on our website from time to time, except in cases of
 obvious error.
- Prices are liable to change at any time, but changes will not affect bookings in respect of which we have already sent you an email acknowledging your booking.
- It is always possible that, despite our best efforts, some of the investigations listed on our website may be incorrectly priced.
 If the correct price of an investigation is higher than the price stated on our website, we will normally, at our discretion, either contact you for instructions before the date of your appointment, or cancel your booking and notify you of the cancellation.
- We are under no obligation to provide you with an investigation or check –up at the incorrect (lower) price, even after we have sent you an email acknowledgement, if the pricing error is obvious and unmistakeable and could have reasonably been recognised by you as a mis-pricing.
- Payment for all website bookings must be by credit or debit card. A deposit payment of £50.00 will be taken at the time you make your booking.
- Payments of any outstanding or shortfall of payment after you visit can also be made online

4. CANCELLATION BY YOU

- You may cancel your booking at any time up to and including six working days (i.e. Monday to Friday excluding Public or Bank Holidays) prior to the date of your appointment without incurring any costs.

5. CANCELLATION BY US

- If we believe that the chosen investigation /medical check is not suitable for you for whatever reason.

- Whilst we endeavour to maintain the highest standards it should be noted that no medical Check assessment is 100% effective..
- If you have any specific symptoms or health concerns then the results of an investigation /medical check should be viewed in conjunction with an appropriate clinical opinion.
